Also include your check payable to Steven Restivo Event Services, Inc. Once your application is accepted, you will receive an acceptance letter within 1-7 business days. Next, you will receive a participant packet 20 days prior to the event with all of your set up information and free promotional postcards. If you do not hear from us within ten days of sending the application, please call us to make sure we have received it.
